EXPLANATORY NOTE TO STATEMENTS SHOWING GENERAL PROGRESS OF CO-OPERATIVE SOCIETIES IN THE SEVERAL PROVINCES DURING THE YEAR 1912-13.

The abstract tables at the commencement show, in the form decided upon at the last Conference, some of the leading features of progress in the co-operative movement during the year past. The first abstract shows numbers of societies and members, capital and disbursements for the whole of India and the four following abstracts give figures for the same heads by provinces.

The general statements which follow give a complete record of the statistics relating to co-operative societies in the several provinces in India during the year 1912-13. The figures are taken from the advance tabular statements forwarded by the Registrars of co-operative societies for the last year and are classified into three divisions according as they relate to Central, Agricultural or Non-Agricultural societies, respectively. The statements include statistics for societies of a co-operative nature in all the British provinces except the North-West Frontier Province and Baluchistan. In the former the movement has as yet made little progress, while in the latter it has not yet been thought expedient to apply the Act. Figures for the Native States of Mysore and Baroda have been included.

Statement I.—This statement deals with the general progress of the societies and is divided into three parts, I-A, I-B, and I-C, according as it relates to Central, Agricultural or Non-Agricultural societies, respectively. The total number of societies has risen during the year to 12,324 as against 8,177 last year. There are 251 Central, 691 Non-Agricultural and 11,382 Agricultural societies. It will be observed that Agricultural societies have, during the course of the year, increased by 3,820. The total membership and working capital, as they stand at the close of the year, are as follows :—

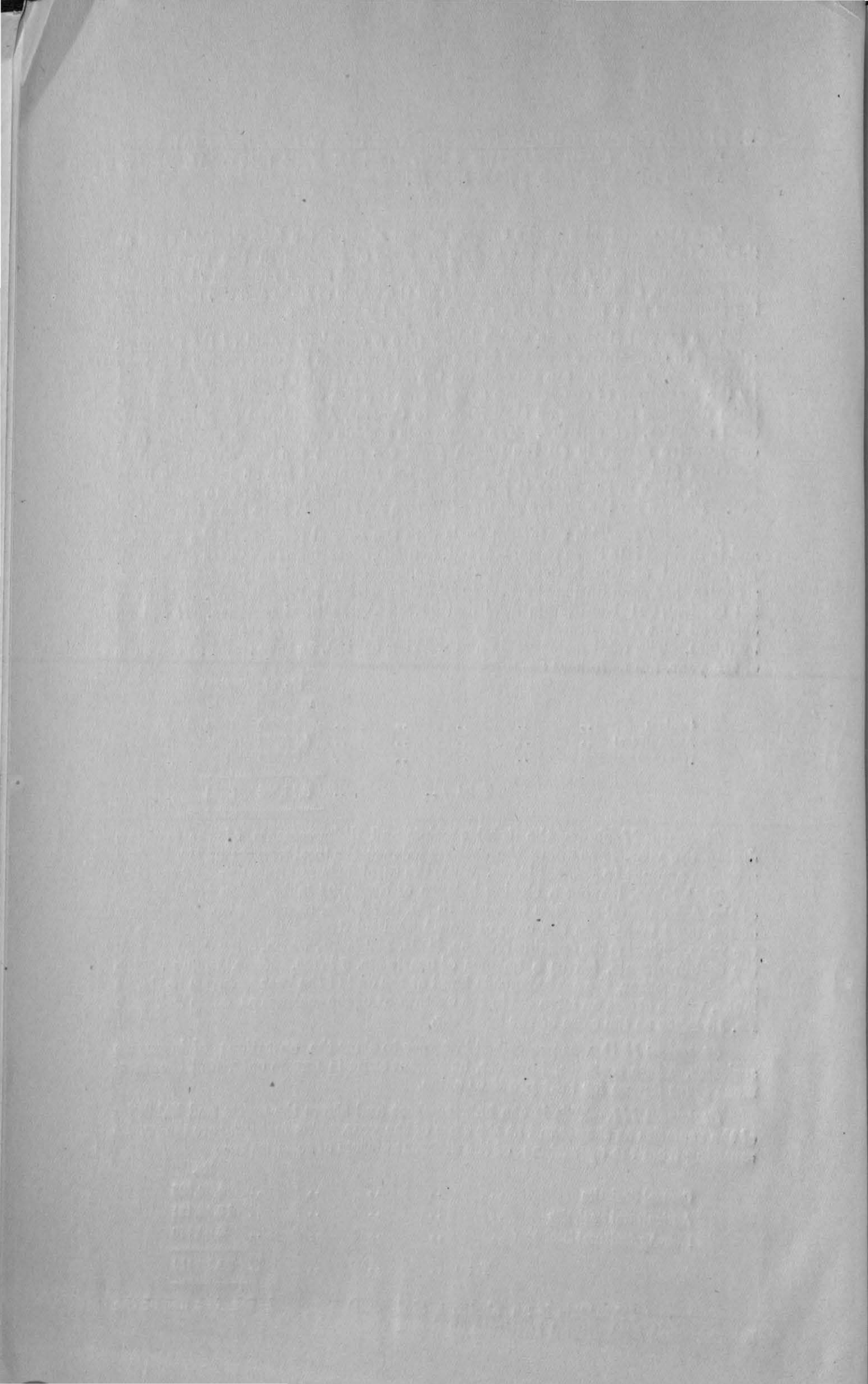
Statement II shows the total receipts and disbursements of the societies during the year. Including the opening balance the total receipts of the Central societies amount to Rs. 325 lakhs, while the total disbursements are estimated at Rs. 315½ lakhs, leaving a closing balance of about 9¾ lakhs. The total income of the Agricultural societies amounts to Rs. 347 lakhs, as against an expenditure of Rs. 333¾ lakhs. In the case of Non-Agricultural societies, the total income of the year, including the opening balance, is Rs. 132 lakhs, which, after deducting all the disbursements, leaves a balance of nearly Rs. 5 lakhs. Thus, taking all the societies together, the net balance in hand at the end of the year amounts to Rs. 28 lakhs, which shows an advance in the operations of the societies as compared with Rs. 18 lakhs at the close of the last year.

Statement II D was prescribed last year to show the operations of insurance societies. These societies, however, at present exist in Burma only, and the statement gives figures for that province alone.

Statement III.—This is the balance-sheet and shows the assets and liabilities of the societies as they stand at the close of the year. The following are the profits resulting from the operations of the different classes of societies :—
