PREFACE.

THIS volume is issued under the directions contained in the Government of India, Home Department, letter No. 3375, dated the 1st October 1902. It is there laid down that a District Gazetteer should consist of two volumes, A and B, the former containing all the descriptive matter and the latter the detailed statistics. While the future revision of the A volume is left to the discretion of the Local Government, a new edition of the B volume is to be brought out after each census, on which occasion the statistics are to be re-compiled and the volume is to be expanded by adding to it any matter which might be required to supplement the A volume. Thus if there has been a famine since A was published, if a new railway has been opened and so forth, information on these points would appear in B as supplementary to the appropriate chapters in A.

The letter quoted also directs that 'the statistical part of the B volumes should be issued with interleaved blank pages so that those who use it can have the figures of later years written in.' It was not thought necessary, however, in the present instance to interleave all the copies printed as only those required for use in the district offices or at the head quarters of the Local Government will be kept up to date. The number of interleaved volumes has therefore been cut down to 35 and the rest have been issued without blank pages.

A difficulty presented by the statistics of the district is that excluded from it in certain respects and included within it in others are the Feudatory States of Amb and Phulra, whose history and position will be found described in volume A. In the Regulations concerning the Hazara Forests and Upper Tanawal, for instance, they are regarded as forming parts of the district but the Deputy Commissioner's powers of interference are limited and the States are entirely outside the control of the Revenue Administration. This twofold character has led to much confusion in the Census statistics and in some cases has vitiated the conclusions drawn from them, as for instance in the births and deaths returns of Table XI. An effort has been made in the present volume to discriminate clearly between the district in its narrower and the district in its wider sense and in the Tables where any confusion is likely to arise it has been expressly stated whether the figures include or exclude those of the Feudatory States. In the other Tables it goes without saying that these States are not included.

The figures for all the tables were originally compiled in the office or through the agency of the Superintendent of Census Operations, Punjab, but they needed a large amount of correction as well as bringing up to date. This has been done in the Hazara Settlement office by direct communication with the Departments concerned and it is believed that the statistics are now as complete and accurate as the circumstances allow. When they are less reliable than usual a note to this effect has been appended to the Table where they appear.

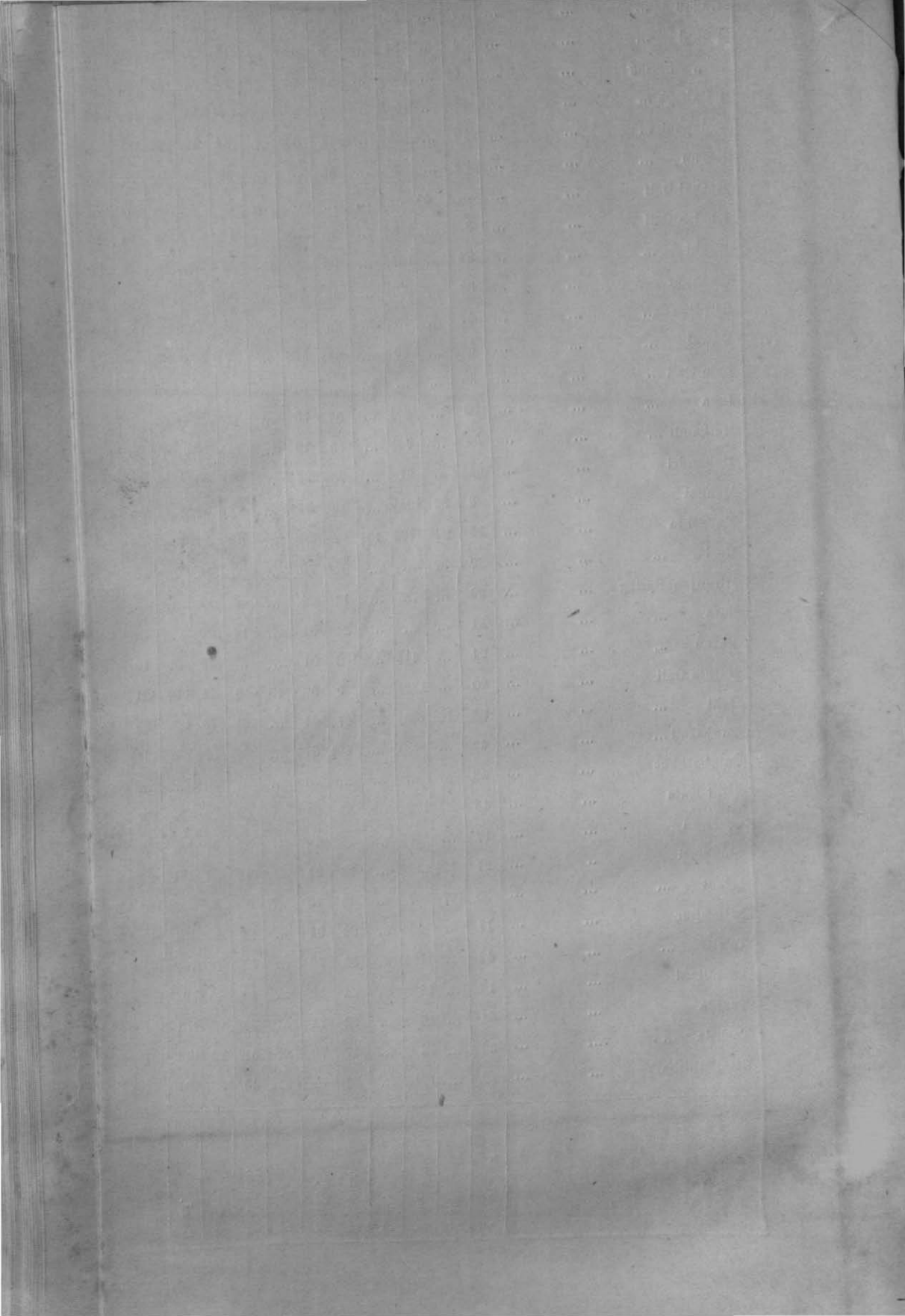
